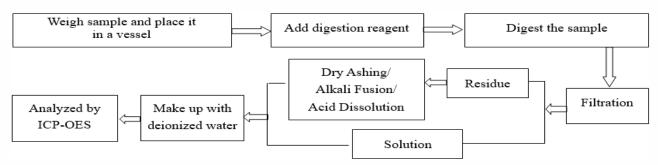

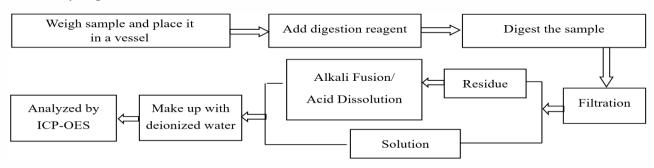

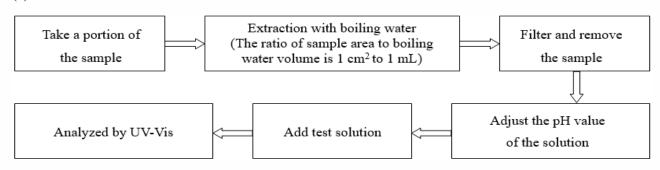


#### 2. Mercury (Hg)

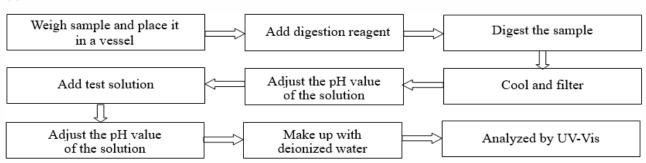


#### 3. Hexavalent Chromium (Cr(VI))

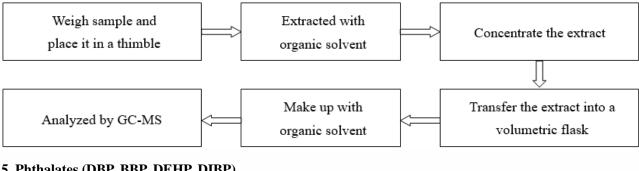

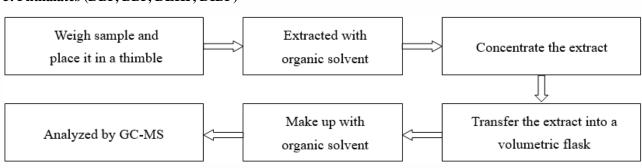

#### 5. Phthalates (DBP, BBP, DEHP, DIBP)



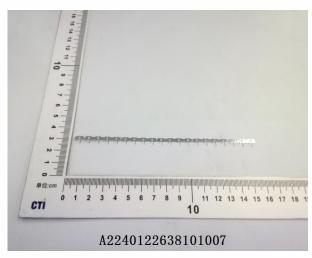
