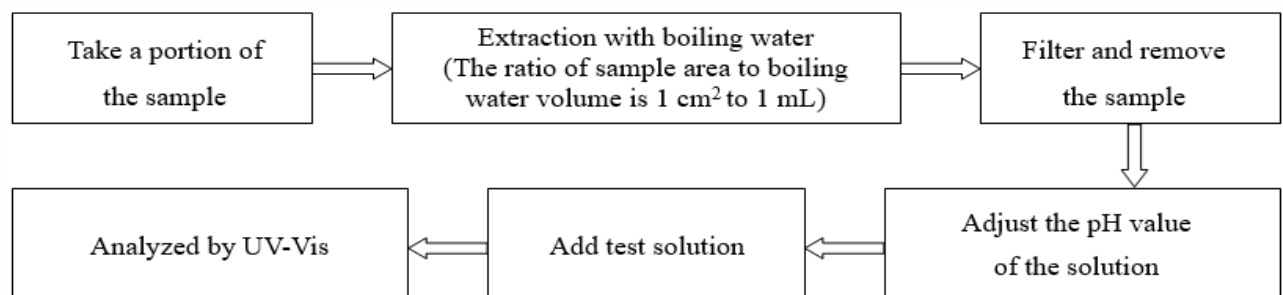

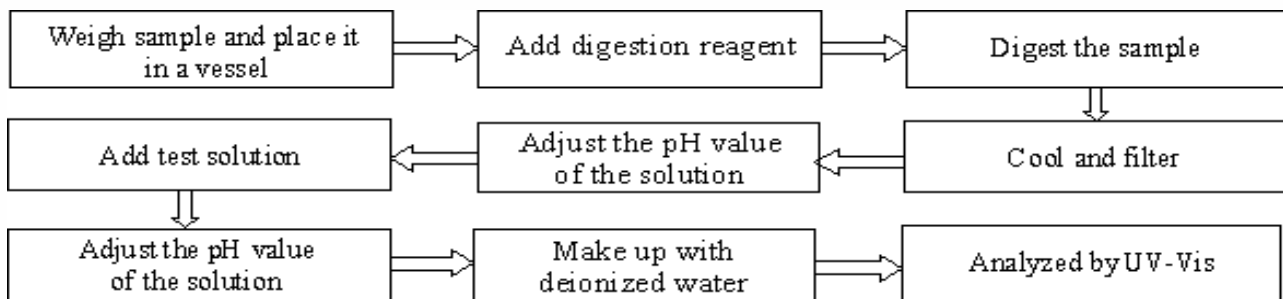


3. Hexavalent Chromium(Cr(VI))
