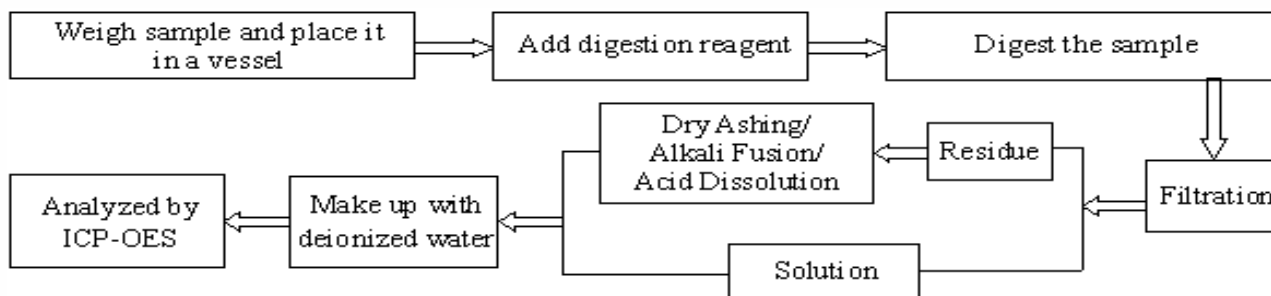

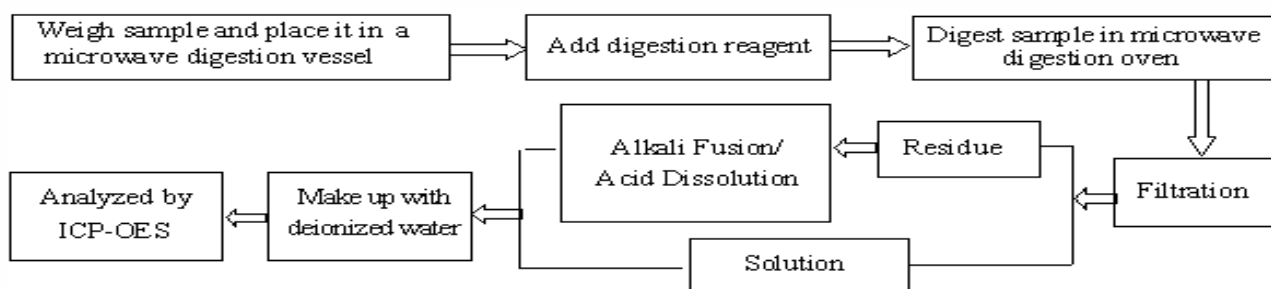

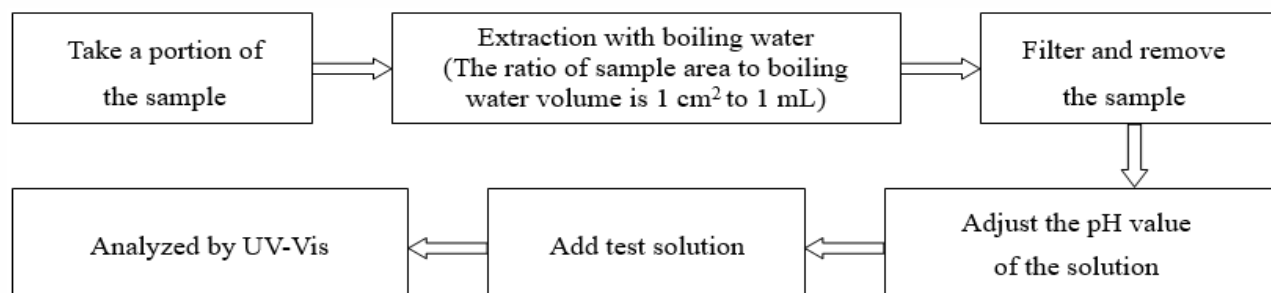


2. Mercury(Hg)

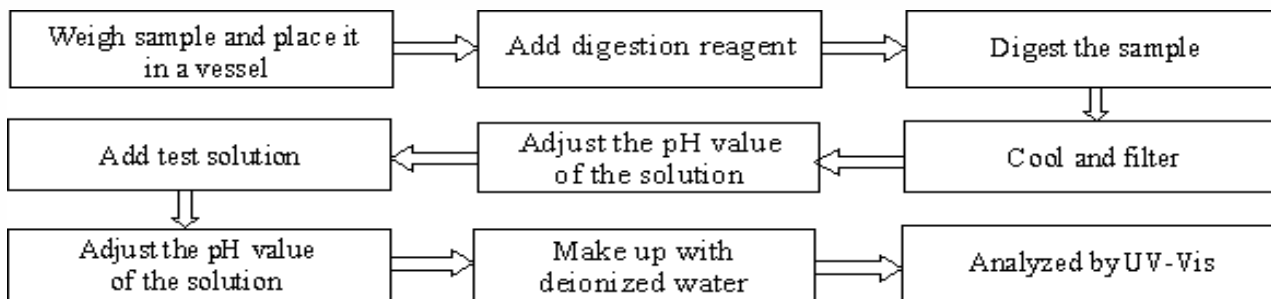


3. Hexavalent Chromium(Cr(VI))

(2) IEC 62321-7-2:2017

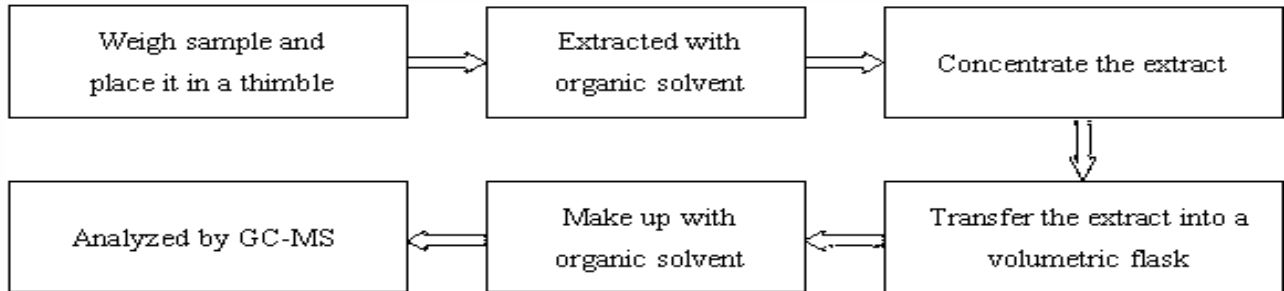
